A great deal has happened in the last month.

First, the St. Claude Avenue Main Street program has become an independent organization separate from our fiscal agent Renaissance Project. This move is beneficial to both organizations and will allow each to better fulfill their mission. We are grateful to Renaissance Project for their support of the program.

Second, our manager Kina has moved on from the organization to seek other opportunities. We are sorry to see her go and wish her the best in her endeavors.

Third, we have hired a new manger, Robyn Blanpied. Robyn brings many years of experience to our Main Street. Most notably she was President of the Friends of Pearl Harbor Historic Trail in Oahu, Hawaii. As President she headed that community non-profit organization whose goal was the sustainable development of Oahu's Leeward/Waianae Coast through tourism and historic preservation. This was conceived as a way to stimulate the local economy of Aiea-Pearl City. The Trail's award-winning Master Plan identified ways to leverage tourist dollars from the popular USS Arizona Memorial to benefit local businesses. We are excited and lucky to have her as our manager.

Fourth, the Board has reorganized the way the Committees interact with the one another and the Board. All committees now will meet on the second Wednesday of the month following the Board meeting. The meetings are limited to an hour and are working meetings. This will facilitate better communication among the different parts that make up the St. Claude Main Street program, and allow us to move forward more efficiently.

PLAYGROUND RENOVATION TO START THE LAST WEEK OF OCTOBER

We are weeks away from the renovation of the playground equipment. The parts are scheduled to ship 10/10 and should be here within two weeks.

The renovation will happen in 3 stages. First, the current playground equipment will be dismantled and taken away to be sandblasted and repainted leaving only the posts behind. Second, the paint will be removed from the posts, and they will be primed and repainted. Once the posts are dry, the playground surface will be pressure washed to prepare the area for the last stage. The last stage is to bring back the repainted, reusable part as well as the new replacement parts and reassemble the equipment.

This whole process should take about 2 weeks barring any bad weather and/or unforeseen issues. We ask that everyone be patient as we go through this process.

We gain would like to thank all those that generously donated to help us raise the more than \$12,000 to renovate the playground equipment. We also would like to thank Calvin Rice, Robert Reddington, Jeff Becker and Chris Costello for spearheading the project and organizing all the bits and pieces to get the project done.

PROJECTS IN THE WORKS

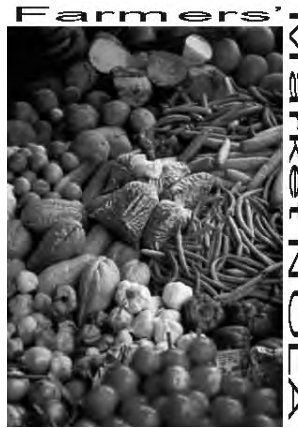
Sts. Peter and Paul Church (2317 Burgundy St.) – **Providence Community Housing** is planning on converting the School, Rectory and the Nun's House into senior housing as well as building a 2 – 3 story building on the parking lot at Mandeville and Burgundy. They were at our August General Meeting to introduce the project and said they will come to another meeting once their plans are more solid.

Mandeville Fire Station (718 Mandeville St.) – Gandolfo Kuhn, L.L.C., a land surveying company wants to lease the building from the City to house their business there. They are still in the negotiation stage of the project.

Gendusa Bakery (1801 N. Rampart St.) – Elizabeth and Kevin Martinez and Michael Seaman are interested in opening up a sound recording studio in the brick building of the Gendusa bakery. They came to a general meeting and board meeting to discuss the project. For this project to happen the zoning will have to be changed to accommodate their use. We are investigating the issues.

839 Elysian Fields Ave. – The project is on hold at this time. They are confident of success of this project at a later date when the real estate market and construction industry stabilize.

NO MORE BLIGHT

There are many properties in the Marigny that have suffered significant damage due to the storm and have not yet been repaired. This poses serious health, fire and safety issues for those neighbors who live next to these properties and to the neighborhood in general.

We have made great strides in identifying these properties in our neighborhood. We will soon be sending letters to the property owners notifying them that their property falls under the City's definition of blight and asking them their plans for their property in hopes that we may help them.

We all want to live in a safe and healthy neighborhood. We are asking these neighbors to help us in rebuilding our neighborhood and City by taking care of their property.

501(c)3: Update

At our September General Meeting, the membership unanimously approved the changes to the Articles of Incorporation. This was a big step in the process of getting our 501(c) status and gave us another opportunity to strengthen our organization.

Since the meeting, the Articles of Incorporation have been submitted to and approved by the State. The next step is preparing the rest of the 501(c)3 application. We would like to thank Robert Rachal for all his work on the Articles of Incorporation and his help in navigating the 501(c)3 process.

Our goal is that by the next newsletter we will have our nonprofit status with the Federal Government.

Once we obtain our 501(c)3 status we will have the opportunity to apply for grants to fund projects in our neighborhood. The renovation of Washington Square Park is on our list. We need your help in identifying projects that need to be done. If you have ideas, please let us know.

Help Rebuild New Orleans - VOTE THIS ELECTION

If we are serious about change then we need to make changes were they will impact us the most. Electing LEADERS will help us navigate the rough path ahead. If you cannot vote on Saturday 10/20 then either vote by Absentee Ballot (due 10/19) or Early Voting in person (Starts 10/6, Ends 10/13 from 8:30 am – 4:30 pm except Sunday.) There are more detailed instructions below.

Besides voting yourself, consider calling or emailing your friends to remind them to vote. Let's make this the best voter turnout in New Orleans history!

HOW TO VOTE ABSENTEE BY MAIL

Absentee ballots may only be obtained from the Orleans Parish Registrar of Voters Office. You may request a ballot by mail or by fax. Absentee ballots must be received by the Registrar of Voters by the close of the business day the day prior to the scheduled election.

You can download an Absentee Ballot request form at http://www.no.org/files/request_absentee_ballot.pdf

The request must include the voter's name, address of registration, date of birth, Social Security number, the mailing address, the reason the person is unable to vote in person and, most important, the voter's signature as it appears on the rolls.

If you have registered to vote by mail and have not voted in a prior election, you must vote in person, either during an early voting period or on a regular election day in order to be eligible to cast an absentee ballot by mail.

Handicapped and housebound citizens can apply for regular absentee voting by contacting the Registrar of Voters Office and requesting the forms for the Housebound Program be sent by mail. The forms must be signed by a doctor and returned to the Registrar's Office in City Hall.

Citizens that return a ballot by fax waive their right to privacy.

EARLY VOTING IN PERSON

Early voting in Person is available 10/6 through 10/13, excluding Sunday. This period covers two Saturdays to accommodate out of town or working citizens. This is an option for those who know they will be out of town on election day or for personal reasons they do not wish to visit their polling site. Early voting in person is available at the Orleans Parish Registrar of Voters Office in City Hall at 1300 Perdido Street, Rm. 1W23 from 8:30 am to 4:30 pm.

Residents of the Westbank may vote early at the Registrar's satellite office at the Algiers Courthouse at 225 Morgan Street.

You must bring a Louisiana Driver's License, Louisiana Special ID or other official picture ID when you vote early in person. If you do not have a picture be prepared to bring other proof of residency such as a utility bill and be prepared to fill out an affidavit.

POLLS WILL BE OPEN 6:00 AM UNTIL 8:00 PM.

Triangle Residents vote at Engine House #09 (449 Esplanade Ave.)

Rectangle Residents (to upriver side of Franklin) vote at Abundant Life Baptist Church (1800 Arts St.)

Rectangle Residents (downriver side of Franklin lake side of Burgundy) vote at Douglas High School (3820 St. Claude Ave.)

Rectangle Residents (downriver side of Franklin, riverside of Burgundy) vote at St. Paul Lutheran Church (2624 Burgundy)

Voters that are in line to vote at 8:00 pm will be allowed to cast their ballots. Voters must provide one of the following: A Louisiana driver's license, a Louisiana identification card or any other generally recognized picture ID. If you do not have a picture ID, then you may present any other identification card plus further information such as a utility bill and a completed Voter Identification Affidavit.

Only one person at a time is allowed in the voting booth. If you are unable to read, an election official may assist you. If you are unable to vote without assistance because of a physical handicap, you must bring a physician's certificate with you or have one on file. Disabled voters may go to the front of the line at their polling place.

What Does The Green Project Do?

The Green Project operates a WAREHOUSE STORE that resells high-quality, salvaged building materials at low cost to the community. The store is dedicated to helping the environment by reducing the amount of usable materials placed in landfills or disposed of improperly.

The Green Project also SALVAGES AND DECONSTRUCTS damaged or collapsed buildings by hand, in a way that saves between 45 and 70 percent of the materials. This preserves New Orleans' unique architectural history and benefits New Orleans' residents by returning their ruined building materials to use elsewhere in the city.

The Green Project store also serves as a local RECYCLED PAINT resource by reclaiming, combining, and reselling surplus paint. This keeps paint out of the region's landfills and water system while providing affordable paint to the community.

The Green Project warehouse serves as a RECYCLING center. We currently recycle cardboard, newspaper, regular paper (plain and colored), aluminum cans and household e-waste (electronic equipment like computers, stereos, printers, monitors, cell phones, etc). We can NOT take plastic or glass because no one in the city can pick it up. We also can NOT accept scrap metal - please take it to a scrap metal yard.

Our GARDEN is blooming. Through our gardening workshops you can learn how to make the most of a small space, recycle your yard and kitchen waste into compost and improve your soil.

RECYCLE FOR THE ARTS merged with The Green Project in 2003. R4A provides art materials to individual artists, schools, art programs, galleries, and other non-profit groups at minimal cost, as well as offers monthly recycled art workshops.

THE GREEN ROOM is an interactive community space that promotes using garbage and salvage as artistic material. The space is used to display the work of local artists and is available for workshops and community events. The Green Project is also involved in GREEN BUILDING & SPECIAL PROJECTS like our solar panels, biodiesel and community outreach.
